Second phase schedule:

- 1. Written test in Italian or English, chosen by the candidate consist of the elaboration of a text on a general topic related to the areas of Doctorate, based on a topic that will be drawn at the beginning of the test, among a shortlist of three topics chosen by the Committee the day before the date of the test which is scheduled for the day: 13/06/2023, at 18.00 at the University of Turin, Via Verdi 8, Rettorato, in Aula BLU (Classroom). The written test will have a maximum duration of 60 minutes.
- 2. Academic and aptitude interview, consist of a discussion on the candidate's curriculum vitae, proposed research project, any publications presented, and a reading comprehension test of a text in a language different from the candidate's native language (English for native Italian-speaking candidates, Italian for candidates with a native language other than Italian) is scheduled for the date of: 13/06/2023 following the conclusion of the written test at the University of Turin, Via Verdi 8, Rettorato, in Aula BLU (Classroom The interviewees will be called in alphabetical order.

Candidates, currently neither resident nor domiciled in EU countries have the right to take the entire test online provided that they make an explicit request one week prior to the date of the test. In this case, both the written test and the interview will take place via videoconference.

The ranking of those admitted to the second phase of the selection is made public through the online publication on the UNISG website (https://www.unisg.it/corsi-iscrizioni/corso-dottorato-ecogastronomia-scienze-e-culture-del-cibo/) not less than ten days before the date set for the second phase of the selection itself.

Publication of the ranking list on the university website is valid and legal as an official communication for all intents and purposes. The absence of a candidate, for any reason, shall be considered a withdrawal of candidacy from the selection procedure.

The written test and the academic and aptitude interview shall take place after formal confirmation of the identities of the candidates present, and after they are informed of the evaluation procedure.

The Committee is dismissed at 10.30 and will reunite again on 13/06/2023, at 18.00 to proceed with the second phase of evaluation of the candidates.
