The applicant took part in the Syllabus Project, which was an ontology development application providing a legal taxonomy repository implemented by the University of Turin about consumer law in several EU languages - focused on the redaction of a database of legal terms appearing in the directives regarding Consumer protection. The core question was connected to the analysis of the translation of the European directives' text in order to facilitate the correct implementation in each national legal order. Ability to take initiative and to think independently. Lorenzo Bairati took part in different groups of research within the projects described above (Uniform Terminology for European Private Law and the Copecl Project). His very wide range of subject matters and his inter- and multidisciplinary, comparative and “European” approach also highlights his independent thinking. His leadership qualities can, for instance, be seen by the fact that he has coordinated as a team leader the studies within the ICT4Law project, by promoting study meetings in order to deepen methodological aspects focused on the proposed achievements and on the coherence of the final goal. He took over his charge by demonstrating to have skills of autonomous organization, and the results demonstrated scientific rigor and a creative way of thinking.
