2. Academic and aptitude interview, consisting of a discussion of the candidate's curriculum vitae, proposed research project, any publications presented, and a reading comprehension test of a text in a language differing from the candidate's native language (English for native Italian-speaking candidates, Italian for candidates with a native language other than Italian) is scheduled for the date of 09/09/2022 starting at 8.30 am in Room 9 (Cascina Albertina). The interviewees will be called in alphabetical order.

Candidates, currently neither resident nor domiciled in EU countries have the right to take the entire test online **provided that they make an explicit request one week prior to the date of the test.** In this case, both the written test and the interview will take place via videoconference.

**The publication of this notice on the University portal holds the legal equivalent to an official communication. The absence of a candidate, for any reason, shall be considered a withdrawal of candidacy from the selection procedure.**

The written test and the academic and aptitude interview shall take place after formal confirmation of the identities of the candidates present, and after having informed said candidates of the evaluation procedure.
